Product

Product description:

Multicem is mainly used to reduce soils settings and improve the stability of weak soils masses. Multicem is a binder of cement and CKD (Cement Kiln Dust), and consists mainly of cement, burnt lime and other calcined minerals. Multicem has similar properties as Lime Cement KC, and thus it is suitable for use in stabilizing clay and other unstable soils masses. CKD is a material derived from the furnace system and it is declared with GWP = 0. The total CO2 emissions from Brevik are instead allocated to all our cements. A2 is therefore not included in the EPD of Multicem.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.





Remarks to environmental impacts

The parameter GWP (A1-A3) includes 152 kg CO2-eq. / tonne klinker (82 kg CO2-eq. / tonne cement) from the combustion of alternative fossil fuels during clinker production. In accordance with the "polluter pays" principle / EN 15804 /, the emissions will be added to the production system that caused the waste. In this EPD, the CO2 contribution from alternative fossil fuels has not been deducted. This is to be able to compare calculated global warming from cement regardless of the status of the waste in different countries.
